Stepwise Planning Process

1. Develop inventory and forecast of emissions - Ongoing
2. Identify a full range of possible actions - **Sept. 28**
3. Identify initial priorities for analysis - **Oct. 26**
4. Review Interim Report - **Nov. 14**
5. Develop straw proposals - TBD
6. Quantify GHG reductions and costs/savings - TBD
7. Evaluate externalities, feasibility issues - TBD
8. Develop alternatives to address barriers - TBD
9. Aggregate results - TBD
10. Iterate to final agreements - TBD
11. Finalize and report recommendations - TBD

Straw Goals Proposal Offered at MWG:

- **2012 or 2015**
 - 10% (maybe 15%) below 2006 levels (using a consumption based approach)
 - Used as a target for the State Action Plan
- **2020**
 - 25% to 40% (maybe 50%) below 2006 levels by 2020
 - 25% used as the “minimum” driver for AB 32-like trading program
 - 40% used as an aspirational goal for 2020 time-frame
 - Trading program “rewards” over-control
 - Also used as “stretch” target for the State Action Plan
- **2050**
 - 90% below 2006 levels
 - Used as an aspirational target for the State Action Plan
- **2100**
 - Zero emission or carbon neutral
 - Used as a visionary goal to push research and innovation
- **Mid-Course Correction every 4 years**

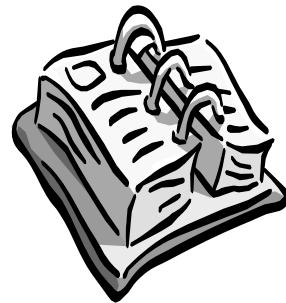
